FACT SHEET

The XTB Emerald Fixed Income Portfolio is a managed portfolio of individual bond units (XTBs) from some of Australia's top companies which have been classified as 'light green' investments.

Portfolio Overview

The Portfolio is made up of companies who are able to provide viable returns to investors while mitigating the environmental and social (ESG) impacts of their business activity. Companies included operate in a manner respectful of society and within emerging ecological constraints.

ESG has become shorthand for investment methodologies that embrace sustainability factors. It is a means for helping to identify companies with superior business models. ESG factors offer portfolio managers added insight into the quality of a company's management, culture and risk profile.

The Emerald Club runs a screen, by conducting an analysis of ESG factors based on a company's annual disclosure of various metrics in its corporate social responsibility (CSR) report. Examples of this include total greenhouse gas (GHG) emissions, water intensity per sales and renewable energy use.

Investment Objective

- A portfolio of ASX-traded XTBs considered to have sound ESG policies
- Investment-grade fixed income securities traded on ASX
- Focus on yield to maturity, liquidity and risk weightings
- A regular and predictable income stream
- A capital preservation focus and low levels of price volatility
- An absolute return that is 1% higher than cash, with liquidity, to ensure investment flexibility
- Risk profile less than equities & hybrids, and a higher return than 'cash-like' investments.
